NS will research likely printing costs for 'shinier version' of draft plan. We'll also need to calculate for another community consultation event and associated costs – food, drink, displays etc.

NS will email Janet Chester to check price of new map requests from Hoople, and email Dave Tristran to see if we need to be calculating funding costs for the actual referendum, or do HC pay for this.

<u>6. Draft Plan</u> – Next stage will be to complete this once all site assessments have been completed.

AT recommends we add extra passage in plan regarding details, of Ashperton Academy School, eg number of pupils.
