Minutes of the Parish Council meeting held at Ashperton Village Hall on Wednesday 27th March 2019 at 7.30pm

The Chairman Cllr Eustace welcomed everyone to the meeting.

1. To Accept any Apologies for Absence and Note the Reason

3. To Note Parish Council Elections 2019

The clerk reminded everyone who wished to stand that nomination papers for the 2019 Parish Elections need to be returned by 4pm on 3rd April to Town Hall, Hereford. Statements of persons nominated will be published on 4th April and if it is a contested election polling day is on 2nd May. If seats remain vacant the parish council are able to co-opt after 7th May 2019.

4. To Consider Approval of Minutes of Parish Council meeting held 30th January 2019

RESOLUTION / ACTION: The minutes were approved as a true and accurate record and duly signed by the chairman.

5. Three Crosses Ward Councillor Report

Ward Councillor Lester advised that Hererfordshire Council debated the full council budget at its meeting in February. Alternative budget options were put forward and were debated for an extra £2m funding but the council budget was agreed. Council Tax was set at the March meeting and a motion discussed what was to do on declaring a climate emergency. The need to be more climate friendly was agreed although Herefordshire Council are already using LED lights and renewable energy through the waste plant. AT the last cabinet meeting a domestic abuse strategy was discussed. Herefordshire Council has purchased the site of The Royal College for the Blind's Southern Campus for £5,395.000. There are currently around 330 Hereford College of Art students doing degree courses on site. Herefordshire Council should obtain rental income from this site of £200,000 per annum.

A local resident expressed their concerns about the condition of the verge and layby opposite the school and on the end of Haywood Lane. There is also a dangerous manhole cover that needs to be inspected by Herefordshire Council / Balfour Beatty. Cllr Lester advised that he would ask for the manhole to be inspected.
